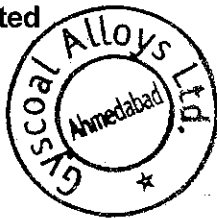



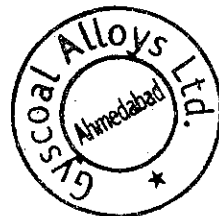

INDEPENDENT AUDITORS REVIEW REPORT

To,

1. 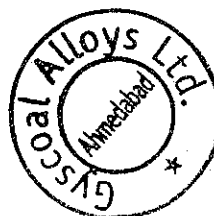

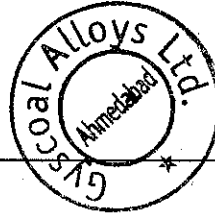


