- 1. We have reviewed the unaudited financial results of M/S STEEL STRIPS INFRASTRUCTURES LIMITED for the quarter ended 30<sup>th</sup> June 2018 which are included in the accompanying 'Statement of Standalone Unaudited Financial Results for the quarter ended June 30, 2018 together with the notes thereon (the "statement"). The statement has been prepared by the company pursuant to regulations 33 of the SEBI (listing obligations and disclosure Requirements) Regulations, 2015(the "listing Regulations, 2015") which has been initialed by us for identification purposes.
