Kanwaris go berserk, videos go viral

Vandalise car after it hit one of them, cops mute spectators

STAFF REPORTER ■ NEW DLEHI

A shocking video on the social media in which a group of 'Kanwaris' are seen vandalising a car upset after a driver allegedly hit one of them on a stretch of busy road near Moti Nagar metro station, even as two cops stand as mute spectators.

The grey i10 car was being driven by a woman, who was with a male friend, when the car allegedly hit a Kanwariya on Tuesday evening. This led to an altercation between a kanwaria and the car occu-

pants. One occupant reportedly slapped the kanwaria. Following which fellow kanwaris got upset and damaged the car.

"Police arrived in 10 minutes but by that time kanwaris had fled the spot. A First Information report (FIR) has been registered CCTV footage is being scanned. In the CCTV footage it is clearly visible that police personnel who reached the spot were trying to normalise the situation," said Vijay Kumar, the Deputy Commissioner of Police (DCP) West district.

"We have identified the



owner of the car and are trying to ascertain the facts and will act accordingly. It is still not clear who was on the steering wheel. However, the owner of the car and the duo who were in the car at the time of the incident, are not willing to come forward and lodge a formal complaint. We have registered an FIR on our own and are investigating", said Madhup Tiwari, Joint Commissioner of Police, South Western Range.

Eyewitness told police that the pilgrims were enraged after the car allegedly hit one of them.

Meanwhile, several people on internet slammed kanwaris for their action, with some even calling them "goons" and "not Shiva Bhakts". Many twitter users called the incident "shameful" one, while many pointed out the Delhi Police's inaction over the incident.

"Most heartbreaking is this

video is chant of "Jai Bhola" ... the Shiv I know doesn't not support this kind to hooligans and goondagardi, why police/administration does not take action against these "goons" and please don't call them "Shiv Bhakt" or "Kanwaris"; one user tweeted. "This happens every year in various areas of Delhi including the highways. Police are always a mute spectator as one can get away with anything in the name of God and religion!!!! Kanvar Yatra is supposed 2 B pilgrimage of devotees of Shiva so do not understand their goondaism!", read another tweet. Another user tweeted, "What's up with police. They are not even making effort to stop this."

The incident caused a traffic snarl and forced some of the terrified commuters to take a detour. And as the kanwaris continued their onslaught, bystanders continue to watch without attempting to stop them.

After rap, Hyatt hotel agrees not to charge ₹200 illegally for parking

After receiving several complaints against Hyatt hotel for hefty parking charges, the Standing Committee Chairperson of South Delhi Municipal Corporation (SDMC) Shikha Rai on Wednesday conducted a surprise inspection and found it to be true as visitors were being charged ₹200 for parking. She instructed the hotel management to follow instructions regarding mandatory free parking issued by the SDMC.

A senior SDMC official said as per the provision in the Master Plan of Delhi 2021 and the sanctioned plans by the corporation, the area reserved for parking cannot be put to commercial use in any manner.

Rai said it has become mandatory for the managements of the hotels, malls and



hospitals to offer free parking in the basements to the visitors in lieu of additional "Floor Area Ratio" (FAR) allowed by the South Corporation.

However, the hotel management stated that ₹200 is being charged only for the valet service and not for the parking but it was noticed by the Chairperson and the Deputy Commissioner that those who refused to avail valet service were being forced to park their vehicles outside the premises of the hotel, a release issued by the SDMC stated.

It further said finally after a brief discussions hotel management agreed to provide free parking to the visitors. "They also agreed that the valet charges will only be charged to those who may like to hand over their vehicle to be parked and brought back by the valet staff," it said.

The release further reads that the hotel management also agreed to properly and prominently displays a notice about the charges for the valet service and free parking for all the visitors in the hotel premises.

Out on bail in murder case, man shot dead in JJ Colony; 3 arrested

In what seems to be a case of revenge, a man was shot dead at Tigris JJ Colony on Wednesday 10 pm. The deceased had recently come out of prison where he was lodged in a murder case. Three persons, including two juveniles, have been apprehended, police said.

Deputy Commissioner of Police (DCP) South District Romil Baaniya stated that the deceased, identified as Saghir, died of bullet and stab injuries. The deceased who recently came out of prison allegedly had some enmity with the accused persons.

Initial probe revealed that it was a case of revenge as it is alleged that one of the accused's brother was attacked by the



deceased in January and his brother was killed in the attack. The deceased and the accused are allegedly distant relatives and they knew each other, DCP added.

During the shooting, two passersby were also injured. They were taken to the hospital and their condition is stable, DCP said.

The motive is allegedly personal animosity. A case has been filed in Neb Sarai Police Station under sections 302 - murder, 307 - attempt to murder and 25/27 of the Arms Act, he said.

Minor raped by neighbour in December delivers baby

A 16-year-old who was raped by her neighbour in December last year delivered a baby in hospital at Gurugram on Wednesday night.

The victim who hails from Chhapra in Bihar and lives in Rajiv Nagar near Sector-14 and was doing her Class X from open school. Her father works in a private company in

Gurugram.

According to police, the victim discovered she was pregnant when she developed a "stomach ache" last week. "Even her parents were not aware about her pregnancy. She gave birth to child on Tuesday night," said police official.

"In her complaint she had alleged that her neighbour Rajan Tiwari raped her for the first time in November and later on a few occasions in

December last year threatening to kill her parents and younger brother," said Subhash Bhooken, Public Relations Officer (PRO) of the Gurugram Police.

Tiwari hails from Gonda district of Uttar Pradesh. "The victim's statement was recorded in the presence of her advocate and a case has been registered against the accused Tiwari. We have arrested the accused and further investigation is on," said Bhooken.

Teacher held for slapping student several times

NEW DELHI: A Government school student in Khanpur, New Delhi was allegedly slapped on his ear two-three times by his teacher Mahesh Meena. A case was registered in Neb Sarai police station on Wednesday and the accused was apprehended, police said.

The student alleged that on July 26, he asked the class monitor for a duster to clean

his desk. His teacher Mahesh Meena ordered the monitor not to give him the duster and slapped the student. The next day he informed his mother about the incident and was taken to Hamdard Hospital, police said.

According to police, on August 3, police received this information through Hamdard Hospital but the student

refused to give any statement at the time and told the police that he would give his statement later. On Tuesday, the student gave his statement to the police.

A case under section 325 of the Indian Penal Code (IPC) which deals with voluntarily causing injury has been registered against the accused at Neb Sarai police station.

Missing woman's body found in Najafgarh drain, daughter still missing

A 23-year-old woman's body was found floating in the Najafgarh drain under the jurisdiction of Dwarka district on Wednesday morning.

The deceased, identified as Sonika, used to live in a rented accommodation in Najafgarh's Sangam Vihar area with her husband Pawan Kumar Negi and a six-month-old daughter. Pawan's daughter is also missing since then.

Police said a call was received on Police Control Room (PCR) that a body was floating in the drain. A police team reached the spot and with the help of locals, the body was fished out.

"During investigation it came to light that on Tuesday around 12.05 pm, Pawan, who hails from Garhwal in Uttarakhand, had lodged a missing report about his wife

Sonika and daughter at Najafgarh police station," said a police officer.

Pawan had lodged a complain with police on Monday last about his wife who had gone missing. He informed police that he was informed by his landlord that his wife had left for Aganwadi around 11 am with her daughter and had not returned.

Following which he contacted all his relatives both in Delhi and Uttarakhand but could not find her whereabouts," said police official adding further that the couple have been married for three-and-a-half years. Police said that it has been found that Pawan and his wife were not on good terms and they used to fight quite often. Body has been sent for post-mortem examination at Rao Tula Ram Hospital. Police were trying to trace their six-month-old daughter, said the police official.

28-yr-old man's body found near Narela, no arrest made yet

The body of a 28-year-old man was found lying on a street near the border of Delhi's Narela and Haryana's Safiabad on Wednesday at around 6:50 am.

The deceased, identified as Karan, was allegedly beaten to death, police said. DCP (Rohini) Rajneesh Gupta stated that Narela police station received information on Wednesday morning that a body was found lying on the border of Safiabad. The deceased was later identified as Karan, resident of Safiabad, Haryana.

He left his house at about 10pm on Tuesday and didn't return home. His body was found the next morning. His father is a goldsmith and their house is situated just 1.5 km away from scene of crime. The victim received injuries on his face and head, DCP added. Prior to the incident, relatives alleged that Karan called them and told them that he got into a fight. He didn't recognise the people he was fighting with. Relatives said that they only heard that there was a fight in the vegetable market, police said. The body has been sent for postmortem. However no arrest has been made in this regard, they added.

Hike in MLA LAD fund: North civic agency says money be given to corporations instead

Criticising the Delhi Cabinet's decision to hike MLA Local Area Development (LAD) fund, leaders of North Delhi Municipal Corporation (NMC) said the money should be given to the corporations under plan head instead of increasing LAD fund.

Mayor of North Delhi Adesh Gupta said the Centre has been issuing funds to the civic bodies through State Governments, which is used in developing civic amenities. "Delhi was also following it but since the Aam Aadmi Party Government came to power, everything changed.

Standing Committee Chairperson Veena Virmani appealed the Delhi Government to immediately allocate the funds to the Corporation. "The Delhi Government's unit DSIIDC is responsible for taking care of industrial area in Delhi but due to its failure, most of the



industrial areas in the city are in deteriorating condition. "The civic services in Kirti Nagar industrial area are in the bad shape too. There are potholes in the roads, drains are choked and water-logging is rampant in most of the industrial areas," she said. Leader of House Tilak Raj Kataria said that Delhi Government is responsible to maintain all the roads which are above 60 feet. "It includes maintenance work of footpaths, central verges, and drains on these roads. However, instead of focussing on its work, the government is trying to work on roads that fall under the jurisdiction of Municipal Corporations through MLA fund," he said.
