

में चार खाद्य निरीक्षकों के नेतृत्व में टीम गलतागेट थाने पहुंची। जहां सामने आया कि यह मिठाईयां दुध का पाउडर, सूजी व अन्य खाद्य सामग्री से मिलाकर बनाई गुई है। सीएमएचओ नरोत्तम शर्मा ने बताया की 1650 किलो मिलावटी मिठाई पकड़ी है। इनमें मिल्क केक, टोडा बर्फ सहित मावा जब्त किया गया है। वहीं बाहर से ला रहे मिलावटी मिठाईयां और मावा ले जाने वाले वाहन पिकअप व बोलेरो को जब्त कर चालक देशराज गुर्जर, गोपाल दास और महेश कुमार को पुलिस ने गिरफ्तार कर लिया है। खाद्य निरीक्षक सशील चोटवानी ने बताया कि खैरथल के ऑल मिल्क शॉप, अनिल कुमार ईश्वरदास, अमन मिल्क प्रोडक्ट्स, वेद मिल्क प्रोडक्ट्स के यहां मिठाई बनकर तैयार हो रही थी। इसमें ग्लूकोज, मिल्क पाउडर, सोयाबीन का तेल और सूजी का उपयोग कर तैयार किया जा रहा था। जब्त मिलावटी मिठाई को नष्ट करवा दिया गया।

खास बात यह है कि यह मिठाई खैरथल, अलवर से 90 और 100 प्रति किलो में मंगवाई जा रही थी, जिसे यहां 300 से 350 रुपए तक में बेचा जा

# मेघ, आमागढ़ कच्ची किकर मकान पर गिरी

## ह लोग घायल, तीन की हालात गंभीर

एयरपोर्ट पर एक इंच बारिश दर्ज की गई। उधर ट्रांसपोर्ट नगर इलाके में आमागढ़ कच्ची बस्ती की पहाड़ी से चट्टानें भी बारिश के चलते खिसककर धराशायी हो गई। पहाड़ी से सरककर चट्टान के टुकड़े और बड़े-बड़े पत्थर बस्ती में बने हुए मकानों पर गिर गये। इससे जहां कई मकान धराशायी हो गये। डीसीपी ईस्ट गौरव यादव ने

बताया कि हादसे में मेहबूब (60) की मौत हो गई और करीब आधा दर्जन लोग घायल हो गये। हादसे में रशीद (40), जमीला (55), वकीला (30), सोहेल (8) और साहिल (10) शामिल है। उन्होंने बताया कि सोबिल, साहिल और वकीला को उपचार के बाद छुट्टी दे दी गई है और अन्य तीन लोगों का उपचार जारी है। जिन्हें स्थानीय निवासियों की मदद से पुलिस ने अस्पताल पहुंचाया।

बताया जा रहा है कि मलबे में दबने के कारण युवक गंभीर घायल हो गया या, अस्पताल पहुंचाने के कुछ देर बाद

ही उसने इलाज के दौरान दम तोड़ दिये। सूत्रों ने बताया कि आमागढ़ में पहाड़ के नीचे कुछ लोगों ने मकान बना लिये। सुबह से ही रूक-रूककर हो रही बारिश के चलते चट्टान में आई दरारें और गहराती गई। अचानक भरभराकर चट्टान पहाड़ी के नीचे बने मकानों पर गिर पड़ी। इससे बस्ती में हडकंप मच गया। मकानों पर भारी पत्थर गिरने से महिलाएं और बच्चें मकानों में ही फंस गये।

लोगों की सूचना पर सिविल डिफेंस, एसडीआरएफ, पुलिस, वन विभाग और जिला प्रशासन के लोग मौके पर पहुंचे। स्थानीय लोगों की माने तो सुबह की बारिश के बाद पहाड़ से लाल मिट्टी गिरना शुरू हो गई थी। जिसे देखकर कुछ परिवार तो निकलकर बाहर आ गए थे। जबकि कई लोग तो मिट्टी गिरने पर भी नजरअंदाज करते रहे। इधर मौसम विभाग ने आगामी दो दिनों में पूर्वी राजस्थान में भारी बारिश की संभावना जताई है।
