The 66th Annual General Meeting of the Company was held at Thane One, DIL Complex, Ghodbunder Road, Majiwade, Thane (West) - 400 610, Maharashtra on Friday, September 28, 2018, which commenced at 3.00 p.m. and concluded at 5.30 p.m.

Deodhar & Co., Company Secretaries having office at 4/3 Radha, 1st Floor, Shastri Hall, Grant Road (West), Mumbai 400007 was appointed as Scrutinizer for the purpose of scrutinizing the E-voting process, Postal Ballot and Physical Ballot Process in a fair and transparent manner for the resolutions to be passed at the 66th Annual General Meeting of the Company held on Friday, 28th September, 2018 at 3.00 P.
