I V. N. Deodhar, proprietor of M/s V. N. Deodhar & Co., Company Secretaries having office at 4/3 Radha, 1st Floor, Shastri Hall, Grant Road (West), Mumbai 400007 was appointed as Scrutinizer for the purpose of scrutinizing the E-voting process, Postal Ballot and Physical Ballot Process in a fair and transparent manner for the resolutions to be passed at the 66th Annual General Meeting of the Company held on Friday, 28th September, 2018 at 3.00 P. M. at Thane One, DIL Complex, Ghodbunder Road, Majiwade, Thane (West), 400610 and ascertaining the requisite majority on E-voting as well as Postal Ballot and Physical Ballot carried out as per provisions of the Companies Act, 2013 ("the Act") and Sub rule (xi) of Rule 20 of the Companies (Management and Administration) Rule, 2014 and in accordance with Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations,2015. The Company sought approval of Members to the Resolutions via E-Voting, Postal Ballot and Physical Ballot Process:

- 1. The E-voting period commenced at 9.00 a.m. on Tuesday, 25th September, 2018 and ended at 5.00 p.m. on Thursday, 27th September, 2018. The E-voting module was disabled by CDSL for voting thereafter.
- 2. Voting rights were on the paid-up value of shares registered in the name of the member as on the Cut Off date i.e. 21st September, 2018.
- 3. The Shareholders holding shares as on the "Cut Off" date i.e. 21st September 2018 were entitled to vote on the proposed 5 (Five) Resolutions as mentioned in the Notice of the 66th Annual General Meeting of the Company.

- 4. At the venue of the 66th Annual General Meeting of the Company held on 28th September, 2018, the facility to vote through Physical Ballot was provided to facilitate those members present in the meeting and had not participated in the Remote E-voting and Postal Ballot to record their votes.

- 6. After tabulating the votes cast at the venue of the Annual General Meeting through Physical Ballot and the votes cast through Postal Ballot, the votes cast through Remote E-voting were unblocked in the presence of two witnesses, namely, CA. Hrushikesh V. Deodhar and Mr. Ajit Ukidwe, who acted as witnesses and who are not in employment of the Company.
