<u>Gist of the proceedings of the 86thAnnual General Meeting of Bajaj Hindusthan Sugar</u> <u>Limited held on September 21, 2018</u>

The 86thAnnual General Meeting (the "Meeting") of the Members of the Company was held on September 21, 2018 at 11:00 A.M. at the Conference Hall, General Office, Bajaj Hindusthan Sugar Limited, Golagokarannath, Lakhimpur-Kheri, District Kheri, Uttar Pradesh 262802 and the meeting concluded at 12.10 P.M.

Since Mr. Kushagra Bajaj, Chairman, could not attend the meeting, Mr. D.K. Shukla, Director was unanimously elected as Chairman and chaired the proceedings of the meeting.

The requisite quorum being present, the Chairman called the meeting to order.

Mr. Ashok Kumar Gupta, Director (Group Operations) gave an overview of the financial performance of the Company for the financial year ended March 31, 2018 and its future outlook. The Chairman of the meeting invited the shareholders to raise their queries, if any, on the account for the year 2017-18. No one raised any query.

The Chairman informed the Members that pursuant to the provisions of the Companies Act, 2013, Rules framed thereunder and Regulation 44(3) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015, the Company had extended remote e-voting facility to the Members of the Company in respect of resolutions to be passed at the Meeting. The remote e-voting commenced at 9:00 A.M. on September 18, 2018 and ended at 5:00 P.M. on September 20, 2018.

The Chairman also informed the Members that the facility for voting through ballot is made available during the Meeting for Members who have not able to cast their vote through remote e-voting.

The Chairman further informed that the Company has engaged the services of Central Depository Services (India) Limited ("CDSL") as the agency for providing e-voting facility and have appointed M/s. Gupta Baul & Associates, Practicing Company Secretaries, as the Scrutinizer for the purpose of scrutinizing remote e-voting process and Mr. Avinash Chaturvedi, Advocate, as Scrutinizer to conduct the Poll process at the AGM Hall.

Thereafter, all the 4 (four) resolutions required to be passed were proposed and seconded. Thereafter, the Chairman ordered a Poll to be taken at the meeting and requested Mr. Avinash Chaturvedi, Scrutinizer for an orderly conduct of the voting.

The Chairman announced that the e-voting results along with the consolidated Scrutinizer's report shall be placed on Company's website and the website of CDSL.

The following items of business as set out in the Notice convening the 86th Annual General Meeting were commended for Members' consideration and approval:

- 1. Adoption of Standalone and Consolidated Financial Statements of the Company for the financial year ended as at March 31, 2018 and the Reports of the Board of Directors and the Auditors thereon for the said year (Ordinary Resolution).
- 2. Re-appointment of Mr. Kushagra Bajaj (DIN: 00017575) as Director, who retires by rotation and being eligible offers himself for re-appointment (Ordinary Resolution).

SPECIAL BUSINESS:

- 3. Appointment of Mr. Rajeeva (DIN: 08128796) as Nominee Director of the Company, liable to retire by rotation (Ordinary Resolution).
- 4. Ratification of the remuneration payable to cost auditors for the year 2018-2019 (Ordinary Resolution).
