




We, B. Bhushan & Co.(Company Secretaries) appointed as Scrutinizer(s) for the purpose of the e-voting and poll taken on the below mentioned resolution(s), at the 33<sup>rd</sup> Annual General Meeting of the Equity Shareholders of **Swagtam Trading and Services Limited** (CIN :- L51909DL1984PLC289131) having its Registered office at **R-489, GF-A, New Rajinder Nagar, New Delhi-110060**, held on **25<sup>th</sup> September, 2018** at R-489, GF-A New Rajinder Nagar, New Delhi-110060, submit our report as under:

1. The Company has informed that, on the basis of Register of Members and List of Beneficial Owners made available by the Depositories viz: NSDL/CDSL the company completes the dispatch of Notice of AGM on 17<sup>th</sup> August, 2018.
2. The voting rights were reckoned as on 19<sup>th</sup> September, 2018 being the cutoff date for the purpose of deciding the entitlement of the members at e-voting and voting at the AGM.
3. The Company has appointed NSDL as the agency to provide the E-voting platform.
4. E-Voting platform was opened from 21<sup>st</sup> September, 2018 (9.00 A.M.) to 24<sup>th</sup> September, 2018 (5.P.M.).
5. As prescribed under The Companies Act,2013 and Rules framed there under, the scrutinizer shall have access after the closure of period of e-voting and before the start of AGM, to only such details relating to the members who have cast their vote, such as their Name, Folio No., number of shares held, but not the manner in which they cast their vote. And accordingly the NSDL had provided the same to us.
6. On completion of the meeting NSDL provide us the details to the e-voting results with the list of members who have cast their vote electronically with their shareholding details and details on vote on each resolution.
7. We unblocked the e-voting results in the presence of Mr. Atara Chandra and Mr.Sada Shiv Das who are not in the employment of the company and download the results.



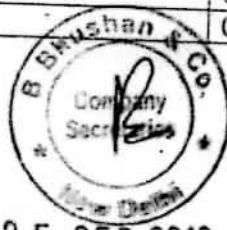
