भारत-चीन में सीमा प्रबंधन पर चर्चा

बेजिंग, 27 सितंबर (भाषा)।

भारत और चीन के महत्वपूर्ण सीमा तंत्र की गुरुवार को बैठक हुई। इसमें सीमाई क्षेत्रों के प्रभावी प्रबंधन और आपसी विश्वास बढ़ाने के मकसद से विश्वास बहाली उपायों पर विचार किया गया। भारतीय दूतावास की ओर से जारी बयान में बताया गया कि भारत चीन सीमा मामलों पर विचार-विमर्श और समन्वय के लिए कार्यकारी तंत्र (डब्ल्यूएमसीसी) की 12वीं बैठक सिचुआन के चेंगदु शहर में हुई। बयान में कहा, 'दोनों पक्षों ने भारत-चीन सीमाई क्षेत्रों की स्थिति की समीक्षा की। उन्होंने वुहान शिखर वार्ता में दोनों देशों के नेताओं द्वारा उपलब्ध कराए गए सामरिक मार्गदर्शन के मुताबिक सीमाई क्षेत्रों के प्रभावी प्रबंधन पर विचार-विमर्श किया।'
