Proceedings of Annual General Meeting of the Company held on Friday, September 28, 2018 at 12.00 noon.

The 87th Annual General Meeting of the members of the Company was held on September 28, 2018 at 12.00 noon at the registered office of the Company at 601 & 602, N.S. Patkar Marg, Girgaum Chowpatty, Mumbai 400 007.

Mr. Tilak Raj Bajalia chaired the meeting. The requisite quorum being present, the Chairman called the meeting to order. All the Directors of the Company were present at the meeting. The Chairman delivered his speech and the Notice of the meeting was taken as read.

The following resolutions as set out in the Notice convening the AGM were proposed and seconded by the Members:

ORDINARY BUSINESS:

- 1. Adoption of Balance Sheet, Statement of Profit & Loss, Report of the Board of Directors and Auditors for the financial year ended March 31, 2018 (Ordinary Resolution).
- 2. To declare final dividend on equity shares (Ordinary Resolution).
- 3. Re-appointment of Mr. Hemant Panpalia who retires by rotation (Ordinary Resolution).
- 4. Appointment of M/s. CLB & Associates, Chartered Accountants as Auditors and fixing their remuneration (Ordinary Resolution).

SPECIAL BUSINESS:

- 5. Appointment of Mr. Tilak Raj Bajalia as Independent Director (Ordinary Resolution)
- 6. Approval of Related Party Transactions under Regulation 23 of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulation, 2015 (Ordinary Resolution)

The Chairman informed that the company has engaged the services of Ms. Bhavana N. Pandya & Co., Chartered Accountants as scrutinizer for the purpose of scrutinizing the remote e-voting and the poll process at the AGM.

The Company Secretary informed the members that pursuant to the provisions of Companies Act, 2013, rules famed thereunder and listing agreement, the Company has extended the remote e-voting facility to the members of the Company in respect of the resolutions to be passed at the meeting.

The Chairman thanked the members for attending and participating in the Meeting. The Chairman authorized the Company Secretary to declare the results of the voting.
