CHAIRMAN SPEECH:

Chairman in his speech has explained about the developments in Dairy industry during the year and overview of the financial performance of the Company for the financial year ended March 31, 2018 and future outlook

The Chairman announced that there were no qualifications, observations or comments on financial transactions or matters, which have adverse effect on the functioning of the Company mentioned in the auditor's report on the financial statements for the year ended 31st March, 2018

The Chairman informed the Members that pursuant to the provisions of section 108 of Companies Act, 2013 read with rule 20 of the Companies (Management and Administration) Rules, 2014, the Company had extended the e-voting facility to the members of the Company as on cutoff date 21.09.2018 in respect of business transacted at the Annual General Meeting. The e-voting commenced at 9.00 a.m. on 25th September 2018 and ended at 5.00 p.m 27th September, 2018.

The Chairman informed the Members that Mr. N.V.S Nagaraju, Company Secretary, Partner of K.Srinivasa Rao & Nagaraju Associates., Company Secretaries was appointed as Scrutinizer to conduct the poll and submit his report for declaration of results.

There after Chairman read the Notice to the Members containing the Agenda of the Annual General Meeting.

The Chairman also read in the Meeting the Board's Report to the Members for the FY 2017-18 and Secretarial Audit Report for the Financial Year 2017-18.

The Auditor, Mr. A.Srinivasulu, Statutory Auditor, has read the Auditors Report on the Financial Statements for the Financial Year 2017-18.
